This Schedule 13G (this "Schedule 13G") is being filed on behalf of North Run Capital, LP, a Delaware limited partnership (the "Investment Manager"), North Run Advisors, LLC, a Delaware limited liability company ("North Run"), Todd B. Hammer and Thomas B. Ellis (collectively, the "Reporting Persons"). Todd B. Hammer and Thomas B. Ellis are the principals and sole members of North Run. North Run is the general partner of the Investment Manager. The Investment Manager is the investment manager of certain private pooled investment vehicles (collectively, the "Funds"). This Schedule 13G relates to shares of Common Stock, \$0.01 par value (the "Common Stock"), of PowerFleet, Inc., a Delaware corporation (the "Issuer"), held by the Funds.
