On January 27, 2020, Elizabeth Elkins (the "Reporting Person") was granted options to purchase 15,000 shares of common stock, par value \$0.01 per share, under PowerFleet, Inc.'s (the "Company") 2018 Incentive Plan in consideration of her services as an officer of the Company. These options vest in equal increments over a four-year period commencing on the grant date, such that 25% of the options vested on the first anniversary of the grant date and the remaining 75% of the options will vest on the second, third and fourth anniversaries of the grant date, provided that the Reporting Person is employed by the Company on each date.
